And replace it

Was it stolen from your home?

Yes

Do you have a police report number from the Indio PD?

QSC equipment is going to be very hard to find in used condition and the price won't be marked down by much since it retains its value. Cases will be impossible to find used.

I found top used for sale but what I'm having a hard time to find are the subwoofers

Your making Threats that I stood your stuff and got police Involved when I did not still anything I rent it from you and got stolen from me. I'm going to have to contact a lawyer to see now what my opinion are. Since now this is a civil matter. Your not trying to work with me with few payments options or with other used equipment your asking for over 14k in less than 24 hrs. I'm actually trying to cover this on my own.

I should've toke you the equipment on Saturday but you told me your would not be available and now I'm stuck with this bill

Not making threats at all. If something is stolen, a report has to be filed, which you did not do. No one is saying you stole it, but you are still responsible. I waited for you for three hours on Saturday since you told me you would be returning it by 9:00 am. You also told me you have insurance. If you want to work something out, I'm all ears, but this can't go on forever.

I'm a responsible person trust me i just need to figure it out how I'm I going to get all this stuff. I been in so much stress. You telling me you need it solve by the next day it makes just wanna give up

Or I can't send you 3k every 3 weeks or I can buy the subs from pro sound and stage lighting and just pay you for the tops in 2 payment

But please need to be little patient and everything would work out

At this point, whatever it takes, but three 3k payments doesn't cover \$14,815.85. Tell me how you would like to handle it, but it must be a signed agreement. Trust me, no one is more stressed about this than I am.

I'll be happy to drive to you and sign a agreement and figure something out soon

I'm very sorry for your stress

I'm off sat and Sunday what day would be best for you me to go over and make a agreement and get this taken care of. If I have to I'll sell my truck it's paid off

Just tell me what agreement would work out best for you and we'll go from there.

4000 every month? I'll make that for sure with no issues and extra 1000 for the stress

I get money every 4th of every month from a Settlement I just wanna pay you and get it over with.

I'll sign a contract my email or in person and your for sure get all your money

I can order atleast the subs today and we can just make the rest on 4000 a month ?

They can be delivered to you

If it works out better for you to buy some of the stuff yourself and have it delivered here in order to get a 0% interest plan, that's fine. Otherwise, a payment plan would look like this:
